


DON'T FORGET TO RECERTIFY!

Recertification of your IBHRE designation, by way of re-examination, is essential to maintaining and demonstrating continued competency. Recertification is required every ten (10) years after your initial certification. After the first five (5) years following your designation, you must also attest to have been actively involved in activities that are directly applicable to at least three (3) of the competencies listed in your exam content outline.



3 STEPS TO RECERTIFICATION

- To be eligible for recertification, candidates must:
 - Have 45 contact hours of IBHRE maintenance of certification activities
 - Remain in good standing within the medical community
 - Attest to remaining involved in the field of cardiac rhythm management
 - *Those who fail to meet these requirements will be ineligible to recertify
- Five (5) years after initial certification: attest to 45 contact hours of IBHRE certification-related Maintenance of Certification (MoC) activities
 - IBHRE certificants must file a professional development activities form and pay a processing fee by December 31 of the fifth year of their certification (found on IBHRE website
 - Activities may include [but are not limited to]:
 - Continuing Medical Education (CME) or Continuing Education (CE)
 - IBHRE Committee Service
 - · Lecture/Presentation
 - Publications
 - College or University Credit
 - Industry Training
 - Industry Sponsored Education Presentation
 - Minimum hours must be completed in order to recertify
- Ten (10) years post initial certification: retake examination to maintain certification
 - Certificants must indicate on the exam application that they are taking the exam to recertify
 - All application and exam fees must be paid and the required documents provided
 - Failure to pass the recertification exam will result in the candidate's lapse of certification



WHY DID YOU DECIDE TO ENTER THE FIELD OF PACING/ELECTROPHYSIOLOGY?

I always was interested in electrical circuits, even etching and building my own circuit boards as a teenager. Combined with my love of doing direct patient care and interest in surgical and interventional procedures, EP seemed like a perfect fit. However, none of this would have been possible without the guidance, mentoring, and role models to which I was exposed to during my fellowship at Ohio State. Specifically, Dr. Stephen Schaal and Dr. Carl Leier cultivated my interest in EP, and Dr. Charles Meckstroth (a cardiac surgeon) taught me the right way to implant devices. I am a long way from my initial goal of being a family physician in Mayville, NY on Lake Chautaugua driving my boat to work every day.

WHAT DO YOU LIKE MOST ABOUT THE FIELD OF PACING/ELECTROPHYSIOLOGY?

The ability to have such an immediate impact on a patient's state of health and quality of life is core to many EP procedures. Restoring a normal heart rate and rhythm, the ability to do a procedure that allows a patient to come off of drug therapy, and the restoration of functional status with CRT therapy are just a few of the benefits patients sustain by what we do as EPs.

WHAT FACTORS INFLUENCED YOUR DECISION TO FOLLOW THE LEADERSHIP PATH?

I was fortunate to be in the right place at the right time, again, with the right mentors. After taking and passing the NASPExAM in 1991, I was asked to join the test writing committee. Led by Dr. Seymour Furman and working with many leaders in the field to create examination questions was enlightening, energizing, and inspiring. I always felt that NASPExAM had even more potential to become a certification exam, and this became my primary goal when I was asked to assume leadership of the organization. We have now become the International Board of Heart Rhythm Examiners, with a professional staff and worldwide recognition. This is the result of hard work and commitment of our director and all of the hard working members of our test writing committees and boards.

WHAT ARE YOU LOOKING FORWARD TO THE MOST DURING YOUR TENURE?

I would like to see the IBHRE exam become even more accepted worldwide. We are working with great people on our board and leaders from heart rhythm societies around the world with great success.

DO YOU HAVE ANY WORDS OF WISDOM, PHILOSOPHY, OR QUOTE THAT HAS IMPACTED YOUR DECISIONS OR ANOTHER ASPECT OF YOUR LIFE?

Dr. Charles Wooley, one of my mentors at Ohio State always said, "It is hard to make an asymptomatic patient feel better." I have found that over the years, this one bit of guidance has helped me practice compassionate, effective, and cost-effective medicine.

WHAT WAS THE LAST BOOK YOU READ?

Destiny of the Republic by Candice Millard. This is the story of President James Garfield who was shot by a would-be assassin. The interesting part is that it was not the shooter that killed him, it was his physician. Garfield was an amazing man, and if you read the book, you will wonder where leaders like he was are to be found these days. If you read it, drop me an email and let me know what you think!

WHEN AND WHY DID YOU DECIDE TO JOIN IBHRE AND THE HEART RHYTHM SOCIETY?

HRS was an easy decision. I was hooked after my first NASPE scientific sessions. Here was a group of people with the same interests as me, and a great place to share ideas, get education, and find out about the newest techniques, drugs, and devices. I also wanted to get the Society's journal! Joining IBHRE? When Dr. Furman asks you to join, you join. I could list the outstanding people that I have worked with on the writing committees over the years, and it would be a "Who's Who" of our profession, both physicians and allied professionals. It is has been and continues to be an honor to work with these incredible people.

WHAT IBHRE OR SOCIETY PROJECT (TASK FORCE OR COMMITTEE RELATED) HAVE YOU MOST ENJOYED WORKING ON? WHY?

There have been many, but being chair of the pacing exam writing committee for IBHRE is my greatest love. I always learn so much from my colleagues, and we share such great



camaraderie during our review sessions. If I had to choose only one thing to do, it would be to continue working on this committee with these great physicians, nurses, and technologists.

ARE THERE ANY HEART RHYTHM ANNUAL SCIENTIFIC SESSIONS MEMORIES YOU WOULD LIKE TO SHARE?

I suppose there is really not a single memory that stands out. For me, to walk down a hallway at the sessions, and not be able to get more than a few steps without seeing and greeting a friend/colleague/mentor/trainee/former trainee is the best part. Sometimes it is difficult due to the lack of time for talking as I rush from one commitment to another, but it is still the best part of the meeting for me.

WHAT IS ONE OF YOUR FAVORITE CITIES AND WHY?

Pittsburgh. I grew up there and still have family there. The city has been through difficult times, but has reinvented itself as a medical and "high tech" center. Of course, there are the Steelers!

DO YOU HAVE ANY HOBBIES?

I love to make pizza from scratch and make teaching videos when I have the time. I have been fortunate to have the opportunity to travel internationally, and love exploring new places, meeting new people, and learning about different cultures.

LINKING IBHRE CERTIFICATION WITH PERFORMANCE AND PATIENT OUTCOMES

As IBHRE's certification audience and stakeholders have expanded worldwide, it has become increasingly evident that there is a growing need to provide concrete research that links certification with successful outcomes. IBHRE has tracked concerns from some health care professionals who are unable to show concrete evidence to their employers that the IBHRE certification is a valuable means of validating their skills and knowledge. In 2012, the IBHRE Board of Directors moved to conduct an outcomes-based research study to discover if IBHRE certification has a positive impact on quality patient outcomes.

Headed by Paul Levine, MD, FHRS, FACC, CCDS, a Market Research Task Force was assembled this year to design a hypothesis and research strategy for the proposed study. Although IBHRE plans for this study to eventually encompass all demographics (physicians and allied professionals, both international and domestic), the preliminary study will focus on allied professional EPs within the United States.

The study will present both quantitative and qualitative data regarding IBHRE certified professionals. Measurable outcomes being considered include utilizing patient satisfaction tools; hospital and industry surveys; and performance measures from the Heart Rhythm Society, the National Cardiovascular Data Registry, and similar databases. This study will take approximately two years to complete. The evolving document will be revisited every two to three years as new data is collected. IBHRE anticipates that this study will serve as a good measure for quality, as well as a solid reference tool for regulatory and health policy agendas.

WHAT MAKES IBHRE'S PHYSICIAN EP EXAM SO UNIQUE?

IMAGINE BEING A PHYSICIAN TRAINED IN CANADA OR THE U.K. OR ANY OTHER COUNTRY. You trained in Internal Medicine and Cardiology, and then came to the U.S. for EP training at an approved program. Then you weren't allowed to prove your competency by sitting for The American Board of Internal Medicine (ABIM) EP Board. This is the experience of many physicians who have had all or part of their training at non-U.S. training programs.

The same is true of Pediatric EPs that have had no path to EP Board certification because they went through a pediatric cardiology program rather than a general (adult) cardiology program. By administering this exam, IBHRE not only promotes a global standard of knowledge, but also provides these physicians with the means to validate their skills and competency in the subspecialty of EP.
