

SUPPORTING DOCUMENTATION REQUIREMENTS

Application submission must be accompanied by the full application fee and supporting documentation that provides evidence of your eligibility. This documentation may include:²

- ✔ A letter of recommendation on official letterhead from:
 - ✔ An immediate supervisor, or
 - ✔ A colleague from your place of employment.

- ✔ Certificate of completion or other documentation verifying successful completion of a formal training program or certification.
Or
- ✔ Documentation from an alternative program.

IBHRE offers competency certification to physicians and allied professionals to provide quality patient care in cardiac pacing and electrophysiology. Certifications offered are the Certified Cardiac Device Specialist (CCDS), the Certified Cardiac Device Specialist- Japan Device Representative (CCDS-JDR), the Certified Electrophysiology Specialist (CEPS), the Certified Electrophysiology Specialist – Adult (CEPS-A), the Certified Electrophysiology Specialist – Pediatric (CEPS-P), and the Cardiac Device Remote Monitoring Specialist (CDRMS).

The Board has certified over 10,000 distinguished heart rhythm professionals in more than 50 countries around the globe. Our certification is the official recognition of achievement, expertise, and clinical judgment in the specialty practice of cardiac rhythm device therapy and electrophysiology.

Accredited by the American National Standards Institute, IBHRE certification programs develop and measure competence in cardiac pacing and electrophysiology. We are also recognized by the American Nurses Credentialing Center on Certification as a Tier 3 certification for Magnet status.

OUR CERTIFICATION PROCESS


Candidates pursuing IBHRE certification undergo a comprehensive review and examination process that measure their skills and knowledge in the field of heart rhythm management. Candidates must complete the following process and successfully pass an exam to earn IBHRE certification:

STEP 1: CHOOSE YOUR CERTIFICATION

The first step in the IBHRE certification process is identifying the certification that you are eligible to pursue. IBHRE offers five certifications based on area of expertise and career tracks:

- ✓ Certified Electrophysiology Specialist — Adult (CEPS-A)
- ✓ Certified Electrophysiology Specialist — Pediatric (CEPS-P)
- ✓ Certified Electrophysiology Specialist — (CEPS)
- ✓ Certified Cardiac Device Specialist — (CCDS)
- ✓ Certified Cardiac Device Specialist — Japan Device Representative (CCDS-JDR)
- ✓ Cardiac Device Remote Monitoring Specialist (CDRMS)

STEPS TO CERTIFICATION



STEP 2: DETERMINE YOUR ELIGIBILITY

Eligibility requirements for IBHRE certification vary and are contingent upon the credential that you pursue. Go to IBHRE.org to view current eligibility requirements.

STEP 3: COMPLETE THE ONLINE APPLICATION¹

Begin the certification process by completing IBHRE's application, which is available online at IBHRE.org.

STEP 4: SCHEDULE YOUR EXAM APPOINTMENT

Approximately six weeks after submitting the application, you will receive an email notification with instructions on how to schedule your exam appointment at the nearest available Prometric testing site.

The computer-based multiple-choice exam is delivered in Prometric testing sites around the world. To find the testing site nearest you, visit

STEP 5: SIT FOR THE IBHRE EXAM

- ✓ Plan to arrive 30 minutes before your exam appointment. Candidates who arrive late will not be permitted to sit for the exam.
- ✓ Bring the following with you:

✓ A valid government-issued ID, such as:

- Passport
- State - Issued ID
- Driver's License
- Military ID
- Citizenship Card

STEP 6: WAIT FOR YOUR EXAM RESULTS

You will receive exam results via email within 12 weeks after the exam date. Successful examinees' names will be added to IBHRE's website approximately 30 days later; instructions for retrieving certificates are emailed in the same approximate time frame.
