

### **IBHRE Exam Developer Honorarium Policy**

#### **Purpose**

The purpose of this policy is to define the way all subject matter experts (SMEs) who participate in exam development activities may be compensated for their contributions to IBHRE.

#### **Policy**

The International Board of Heart Rhythm Examiners (IBHRE) may, at the discretion of the Board of Directors, approve a budget for honoraria to be dispensed to IBHRE test writing committee (physician and allied professional) members on a quarterly basis. Based upon the financial sustainability of the organization, a budget for honoraria shall be set by the Board at the beginning of each fiscal year.

Honoraria shall be dispensed to active SMEs according to the extent of their participation. The Board shall approve a schedule of payments which will assign the amount of honoraria given for each activity. Honoraria will be given to SMEs quarterly but may only be granted when included in the approved budget as determined by the Board of Directors from time to time.

Editorial meetings, via teleconference/webinar, to review assessments will be held. This will include the assessment writers and the test writing committee chair(s). These should be quick and focused to ensure the questions are appropriate, relevant and the answer defined properly and the only one that is correct.

IBHRE-C3 items must be complete (include rationale) and accepted/approved for item writers to receive payment. Item writers will not be penalized if they need assistance posting items in the C3 portal (Oasis). Partial payment, however, will not be made. Item writers are expected to submit an assessment twice a year.

**NOTE:** Quarterly payments to subject matter experts are based upon IBHRE's fiscal year of October 1 – September 30. As such, payments are made following the completion of a fiscal year quarter:

- September-December
- January-March
- April-June
- July-September

## Honoraria shall be granted per participation in the following test development and scoring activities.

The following activities will be tracked by Prometric based on participant virtual login, face-to-face meeting attendance, and or ProBuilder on-line editing, followed by

verification by IBHRE staff prior to payment.

<sup>\*</sup>One of two co-Chairs of a writing committee who guides and advises on item development (example: reviewing, editing and approving items) and who facilitates virtual or face-to-face meetings is identified as the "lead certification chair"; a lead certification chair may transfer the position to another chair as required.
